GENERAL CONDITIONS:

1. Separate and distinct rates are to be quoted for each item given above. Offer must be in Rupees per one Kg. only. **Tenders with rates quoted for unit other than per one Kg. will not be considered.** The rates quoted shall be final and there will not be any negotiation. The quantities of waste shown above are approximate. Tenderers (Buyers) shall be allowed to lift such quantity as available at the time of lifting the waste, at the discretion of the management.
2. However, subject to the condition specified in clause (11) hereunder regarding mill's right to appropriate whatever **quantity** for own use, the quantity lifted shall not be less than what is informed at the time of the tender. Failure on the part of the tenderer (buyer) to lift such minimum quantity intimated at the time of the tender shall result in forfeiture of the Security Deposit kept by the tenderer (buyer) and black listing of the tenderer.
3. Tenderers should deposit an amount of INR 15,000/- (INR Five thousand only) with the Office of the mills at Trivandrum Spinning Mills Ltd., Balaramapuram, Thiruvananthapuram, towards Security Deposit /EMD, and can participate in the tender. The above security deposit shall be of a permanent nature and shall not carry any interest. The Deposit shall not be refundable after each tender, unless the tenderers prefer to sever business relationship with the mills for ever.
4. **Tenders shall be sent to** Trivandrum Spinning Mills Ltd., Vizhinjam Road, Balaramapuram, Thiruvananthapuram, Kerala State – 695 501.
5. The last date of receipt of tender is 02 JUL 10 14.00 hrs.
6. The tender will be **opened at 15.00 hr on 02 JUL 10** at Trivandrum Spinning Mills Ltd., Balaramapuram, Trivandrum in the presence of those tenderers present.
7. Prices quoted shall be for delivery ex-mill. Sales Tax, other duties/charges as applicable will be extra to the buyer's account. 'C' Form to be submitted in the case of inter-State sales, otherwise extra tax, as applicable, will be levied. Packing charges @INR 40/-per bale (INR 30/- Borah) will be charged extra.
8. Income Tax (T.C.S), Surcharge wherever applicable, other levies as per the I.T. Act and any other taxes & levies applicable at the time of delivery would be collected at the prevailing rates. If availing TCS exemption Form 27C duly filled and authenticated must be given before taking delivery.
9. **The sales Invoice shall be raised in the name of Tenderer only. No transfer of tendered items to third party shall be allowed.**
10. The tenderer (buyer) should make payment and take delivery of the material within **five days** from the date of letter confirming the sale. A further time of **ten days** (discretion of the management) shall be allowed for lifting the allotted waste. If the tenderer fails to take delivery of the material within this time limit, the company reserves the right to dispose of the waste by suitable means, and the loss arising on the transaction, if any, will be recovered from the defaulter (tenderer), and the tender security deposit will be forfeited and the tenderer will be black listed.
11. The quantity of waste referred to above is only approximate. The mills reserves the right to appropriate for its own use whatever quantity of waste required.
